### Liability.

1. The participants of event are responsible for themselves and participate at their own risk in the event. The participant is aware of the fact that event will be held in the bobsleigh run which is designed for sports equipment such as luge and Bob and that the navigation of skates and shovels is a misuse of the web. The participants are aware of additional resulting risks. The participants know that this is a risk and even serious injury or death can not be excluded.

2. Neither the organizers of the event nor the operator of the luge and bobsled track are not liable for damage caused by participating in the event property and financial losses of the participant.

3. The Promoter accepts no responsibility for health risks or damage to the participant in connection with the participation in the event. It is the sole responsibility of the participants to consider his health before and determine whether his individual skills and his ability to successfully meet the racetrack are sufficient. Participation is at your own risk. The participant confirms that he is in possession of a valid health insurance that comes up in the case of injury to the cost of his medical care. The conclusion of the corresponding additional insurance is suggested to participants. For the injury caused by other participants or external third parties, no liability is also transferred.

4. The Promoter accepts no responsibility for custody objects.

5. The organizer expressly points out that participation under the influence of drugs, medication and alcohol is strictly prohibited.

6. You use the terrain at your own risk. Each participant bears the sole civil and criminal responsibility for all of it, or the use of his sports equipment damage caused. The participant declares with his signature on the consent form waiving any claims of any kind arising in connection with the training and / or competition, against

- The event organizers
- The operator of the luge and bobsled track
- And any other persons associated with the organization of the event.

### Data collection and - recovery

1. The personal data provided by the participant when registering is stored and processed for purposes of implementation and management of the event, including the care of the participant. By registering, the participant consents to the storage of data for this purpose.

3. It is recognized to represent a participant protocol name, first name, date of birth, sex of the participant. By registering, the participant consents to the storage and utilization of personal data for this purpose.

### Final provisions

1. Verbal agreements are not taken in power. Changes to this contract must be in writing. If any provision of this contract be or become wholly or partially invalid or unenforceable, the remaining provisions remain in effect.
